- C. Authorization for President to sign Contract with Sonoma RCD for professional services to implement LandSmart Conservation Planning for Vineyards in Sonoma.

This contract, with maximum compensation of \$14,225, provides funds for Napa County RCD staff to provide technical assistance to Sonoma RCD to carry out LandSmart Planning workshops and to assist with LandSmart farm plan completion and certification. The term of this agreement is July 1, 2015 through June 30, 2017 and funds are derived from a grant agreement between State Water Resources Control Board and Sonoma RCD.

D. Authorization for President to sign Agreement with Friends of the Napa River to jointly develop and carry out Napa Youth Stewardship Council.

This Agreement, with maximum compensation of \$6,908, provides funds for RCD staff to work with Friends of the Napa River to develop and carry out Napa Youth Stewardship Council, a council of high-school students from Napa County. The term of the Agreement is September 1, 2015 through June 30, 2016 and funds for the agreement are derived from Napa County Wildlife Conservation Commission. Other RCD program funds that support youth education will be used to supplement the funds provided through this Agreement.

8. NEW BUSINESS

A. Review and Discussion of District Financial Reports Anna

Anna will present the Accounts Receivable and Cash Flow reports.

B. Adoption of a resolution designating authorization to execute Grant Agreement No. 15-021 (Agreement) to implement 5,000 Oaks Initiative to the President of the Board and designating authorization to negotiate the Agreement and amendments thereto to the Executive Director.

The RCD has been awarded a grant by the State Coastal Conservancy to implement the 5,000 Oaks Initiative in the Napa Valley. A condition of the grant agreement is a requirement that the Board of Directors adopt a resolution "designating positions whose incumbents are authorized to negotiate and execute [the] Agreement and amendments to it on behalf of the grantee. The proposed resolution will fulfill the requirement.

C. Authorization for President to sign agreement with State Coastal Conservancy for implementation of 5,000 Oaks Initiative.

The RCD has been awarded a grant from the State Coastal Conservancy to implement the 5000 Oaks Initiative in the Napa Valley for the benefit of sequestering greenhouse gasses and community engagement and education. Maximum compensation is \$90,000 and the term of the agreement is through September 30, 2023, with all work being completed by September 30, 2018.

These policies have been reviewed by staff, the finance committee and/or the Ad Hoc Policy Review Committee.

E. Discussion and possible adoption of revised salary schedule to add positions and associated salary ranges.

Consistent with the 2015/16 Annual Plan, the positions of Conservation Program Manager I and Conservation Program Assistant have been developed by staff. The salary schedules for these positions need to be adopted prior to announcing and filling the positions. Following is the proposed hourly salary schedule for each new position.

F. Authorize Executive Director to transfer Frances Knapczyk, currently in the position of Stewardship Facilitator, to the position of Conservation Program Manager I (Step 1) and to fill the new position of Conservation Program Assistant.

Staff anticipates the transfer of Frances Knapczyk to the position of Conservation Program Manager to occur on September 26 and the position of Conservation Program Assistant to be circulated immediately and filled in late October or early November. It is anticipated that the adopted budget is sufficient to allow for these actions.

G. Discussion and possible action to authorize President or Executive Director to sign Contribution Agreement with Natural Resources Conservation Service (NRCS) for a project entitled, "Demonstration of drought resilient and carbon sequestration farming practices at Huichica Creek Vineyard, Napa Valley.

This project, proposed to and approved by NRCS, would contribute \$61,000 toward replanting a 2.5 acre block of pinot noir at the RCD's demonstration vineyard. As conceived the 2.5 acre block of pinot noir would be replanted with 1.75 acres of chardonnay and 0.75 acres of mixed apple orchard. Carbon sequestration and drought resilient practices would be incorporated into the replant design (e.g. application of compost, selection of rootstock and covercrop, irrigation efficiency, treatment of ripped vines, etc.). An analysis of the financial impact of the proposed project has been conducted and, with the contribution agreement, results look reasonable. RCD would begin making money from the replant in year 3, we would break even in year 5, and anticipated revenues from the identified block would be greater than current revenues from the block.
