### C. Authorization for Anna Mattinson to travel to South Lake Tahoe to attend CSDA Board Secretary Conference.

The California Special District Association (CSDA) Board Secretary/Clerk training will be held in South Lake Tahoe between October 18 and October 20. The training will cover foundations of the position, understanding Board Member and District Liability Issues, understanding fundamental laws, records retention and management, and rules of order. The estimated cost for registration, travel, and lodging is \$900 and is within the adopted budget of the District.

**E.** Authorization for President to sign Professional Services Agreement with Point Blue for implementation of the STRAW program in Sonoma County.

This agreement provides \$15,000 to Point Blue to implement the Students and Teachers Restoring a Watershed (STRAW) program in Sonoma County and to collaborate with RCD staff implementing the LandSmart for Kids program to share best program practices. The funds for this agreement are derived from a MOU between Napa County RCD, North Bay Watershed Association, and Marin Municipal Water District (fiscal sponsor for NBWA). This agreement is consistent with the intent of the original proposal to NBWA for funding support. The term of the agreement is July 1, 2015 through June 30, 2016.
