- C. Authorization for President to sign agreement with Putah Creek Watershed Group (PCWG) for RCD to provide technical assistance related to implementation of Water Board regulations for irrigated agriculture in the Sacramento Valley.

RCD has provided program and water quality monitoring assistance to the PCWG since 2004. This year, RCD anticipates providing assistance related to requesting approval of a reduced surface water quality monitoring program and requesting approval of a program to address Water Board requirements related to sediment and erosion control plans. Maximum compensation for the period November 1, 2015 through October 31, 2016 is \$4,000.

D. Authorization for President to sign agreement with Marin RCD for Napa RCD to participate in Regional Carbon Farm Planning Project awarded by State Coastal Conservancy Climate Ready Program.

This project is a partnership project between Marin RCD, Gold Ridge RCD, Sonoma RCD, Mendocino RCD and Carbon Cycle Institute. Funds from the agreement are available to develop farm plan templates that encourage conservation practices known to

sequester carbon, provide training to RCD technical staff that will provide conservation planning assistance, and develop 4 "carbon farm plans." Maximum compensation is \$50,000 and the term of this agreement is September 21, 2015 through September 2017. Funds from this grant leverage NRCS Regional Conservation Partnership Program funds that were awarded several months ago.

# E. Authorization for President to sign Memorandum of Understanding with North Bay Watershed Association for Napa RCD to assist with coordination of the 2016 NBWA Conference to be held in Napa in April, 2016.

This MOU provides maximum compensation of \$10,000 to Napa RCD for assistance with coordinating the 2016 NBWA Annual Conference which is being held in Napa in April 2016. RCD staff will assist with coordination tasks such as: venue selection and, food service and logistical details, and venue set-up. The term of this agreement ends on June 30, 2016.
