B. Approve Budget Amendment No. 2 for Fiscal Year 2015/2016

The proposed budget amendment adds \$31,000 in revenue and expense. It reallocates funds in the categories of "salaries and benefits," "services," "and "supplies and other." It also adds \$38,000 to fixed asset: land improvement for work at the Huichica Creek Sustainable Demonstration Vineyard, \$7,000 which is reallocated from "supplies and other" and \$31,000 in "new" revenue (primarily from an existing NRCS grant). Total revenue and expenses rise by \$31,000 for a revised total budget of \$1,487,990.

C. Award of Napa County RCD Directors' Environmental Scholarship. Ad-hoc Review Committee

An Ad-hoc advisory committee was formed to review the applications for the Directors' Environmental Scholarship Award and will recommend a recipient for the \$500 award.

D. Discussion about possible opportunity to provide services to sustain Napa Youth Ecology Corps in Napa County. Leigh

The Napa-Lake Workforce Investment Board anticipates re-releasing a Request for Proposals (RFP) for the Napa Youth Ecology Corps (NYEC) Employer of Record, after their initial RFP was unsuccessful in obtaining any respondents. NYEC is a county-wide workforce training and ecology education program aimed at employing youth and young adults ("at-risk" youth, ages 18-24) while teaching environmental stewardship. NYEC must have an Employer of Record for the program to continue in Napa County and RCD may be in a position to provide all of the requested services or to partner with another entity and provide some of the services. E. Update and discussion regarding formation of a Northern Inner Coastal Range State Conservancy.

Senator Wolk and Assemblymember Dodd introduced legislation (SB1396) to establish a state conservancy to protect, preserve and restore the "Northern Inner Coast Range's" natural, historical, cultural, and other attributes. While no financial appropriations are dedicated to the newly proposed conservancy, the legislation would establish the new conservancy, making it a viable entity to receive future funds (e.g., future bond funds). Counties eligible for inclusion are all or part of Colusa, Del Norte, Glenn, Humboldt, Lake, Mendocino, Napa (eastern portion), Shasta, Siskiyou, Solano, Trinity, Tehema, and Yolo Counties.
