### **GENERAL INFORMATION**

The Napa County Resource Conservation District (RCD or District) will hold a regular Meeting on Thursday, August 9, 2018 at 8:00 A.M. The meeting room is wheelchair accessible. This Agreement is for fiscal year 2018-2019 and provides compensation up to \$13,716.50 for the RCD to facilitate the Napa Youth Stewardship Council, an extracurricular environmental stewardship leadership club for Napa County high school students. The County Wildlife Conservation Commission receives monies from the California Department of Fish and Game fines and settlement, as well as local fines and settlements that are designated for its use, and makes those funds available to local organizations in the form of grants.

### D. Authorize Eric McKee to attend the 47th North American Association for Environmental Education (NAAEE) Annual Conference held Oct. 9-13 in Spokane, WA.

The NAAEE conference is focused on best practices in environmental education, and this year's specific topics are: Building leadership for environmental literacy, Connecting with nature, Conservation and environmental education, Educating for sustainable communities, Green schools and career-connected learning, and Linking research and practice to increase impact. Eric was awarded a scholarship covering the cost of registration and providing him

with a unique training opportunity. He will attend a "Community Engagement: Guidelines for Excellence" workshop during the conference and will be tasked with leading a workshop in Napa County on the topic of building equitable partnerships with underserved communities to implement environmental education.

# A. Authorize a Memorandum of Understanding (MOU) with the Friends of the Napa River (FONR). Frances Knapczyk

FONR wishes to continue its advocacy for the health of the Napa River watershed; watershed education; thoughtful and responsible development along the River and its tributaries; and the completion of the Napa River Flood Control Project. However, it no longer wishes to hire contractors and/or employees to conduct its work. Thus, FONR is interested in creating a formal relationship with the RCD that may allow deeper collaboration with the RCD around FONR functions including one or more of the following: 501(c)(3) status, operations, administration, governance, and finance. Representatives from FONR and RCD have developed an MOU to outline the intention of both parties to explore a collaborative framework, and to define the contours of the exploratory relationship. The next phase in the exploratory process will involve FONR sharing financial information and specific tasks that they would like for RCD to take on in the remainder of FY 2018-2019.
