The Napa County Resource Conservation District (RCD or District) will hold a regular meeting of its Board of Directors on Thursday, December 12, 2019 at 8:00 A.M. at 1303 Jefferson St., Suite 500B, Napa, CA. # A. Authorize President to Sign Amendment No. 1 of City of St. Helena Contract No. 2019-036.

On October 16, 2018, the RCD and City entered into an Agreement for RCD to provide a range of professional services related to assessing and offseting the environmental effects of the dam removal work on York Creek. This amendment provides additional funding and expands the scope of services for the RCD.

# B. Authorize President to Sign LandSmart Agreement with Jackson Family Wines, Inc.

The RCD desires to enter into a Professional Services and Right-Of-Entry Agreement with Jackson Family Wines, Inc. to prepare 11 LandSmart Plans for \$11,440. This dollar amount exceeds the threshold of \$10,000 under which the Executive Director is authorized by Resolution 2019-03 to enter into such agreements on behalf of the RCD.

#### C. Remove Vehicle from the Fixed Asset List.

The RCD traded in its 1999 GMC Sierra Truck, which was a fully depreciated asset, for the purchase of its new pickup. Because it is no longer owned by the RCD, this GMC Truck must be removed from the RCD's fixed asset list.

#### D. Authorize Executive Director to Request Auditing Services Through Napa County.

The RCD was included in Napa County's overall contract for auditing services to be provided by the Brown Armstrong Accountancy Corporation beginning in Fiscal Year 2015-16. To date, the RCD has not received auditing services through this contract, as we have contracted directly with Larry Bain, CPA to meet our annual audit requirements.

RCD's contract with Larry Bain, CPA expires this year without the possibility of an extension. The RCD desires to proceed with the contracting process with Brown Armstrong for the Fiscal Year 2019-20 audit.
