3. **NEW BUSINESS**

A. Authorization for Executive Director to Sign Agreement Number 2CA05026 with the California Department of Forestry and Fire Protection. Lucas Patzek & Jim Lincoln

California Department of Forestry and Fire Protection (CAL FIRE) wishes to enter into an agreement with the RCD to more effectively increase the pace and scale of critical forest management at the landscape level within the area of the RCD's influence. Work will be completed over a two (2) year timeline and work product deliverables will include reports, surveys and scoping efforts as required to complete environmental compliance, per CAL FIRE policy and procedures and all applicable laws. The maximum amount of this agreement is \$200,000, and the agreement is effective through June 30, 2022.
