A. Authorize Executive Director to issue a letter of non-renewal for Agreement No. 2020-09.

Napa RCD executed Agreement No. 2020-09 with Oak Knoll Farming Corporation for vineyard management services. This Agreement stipulates that written notice of non-renewal must be provided at least 30 days prior to the date of the next automatic renewal, which would be December 31, 2022.

6 NEW BUSINESS

A. Authorization to sign Resolution 2022-05 requesting the Napa County Board of Supervisors appoint Directors to the governing board of the District in lieu of election to fill three positions whose terms are expiring. Lucas Patzek

The terms of three Directors – Bruce Barge, Gretchen Stranzl McCann, and Jim Lincoln – expire on November 25, 2022. This resolution officially requests that the Napa County Board of Supervisors reappoint Directors to the positions in lieu of election. Subsequently, the County of Napa will post required notifications of the positions.

B. Presentation and discussion about the Technical Advisory Group (TAG) supporting the Napa County Groundwater Sustainability Agency (NCGSA). Miguel Garcia

Miguel Garcia, Napa RCD's Sustainable Agriculture Program Manager, was appointed to the TAG and currently serves as its chair. He will present on what the TAG's role is in supporting the NCGSA in implementing the Napa Valley Subbasin Groundwater Sustainability Plan, as well as current and upcoming TAG activities.

C. Discuss 2022 Give!Guide campaign and opportunities for Board support. Frances Knapczyk

Napa RCD was selected one of the participating not-for-profit organizations in this year's Napa Valley Give!Guide, a community fundraising initiative coordinated by Napa Valley CanDo. Staff will describe how they plan to promote the giving opportunity via social media, e-Newsletters, and use of incentives. Staff will also provide opportunities for the Board to support the campaign.
