1. CALL TO ORDER, ROLL CALL

A regular meeting of the Napa County Resource Conservation District was called to order at 8:01 A.M. on Thursday, April 14, 2022 by President Bruce Barge. This meeting was conducted pursuant to California Government Code Section 54953 and Governor's Executive Order N-25-20, in that directors participated only by electronic means, through either audio (i.e., teleconference) or video (videoconference), or both. 5. OLD BUSINESS

A. Governance Committee update.

President Bruce Barge provided an update on the associate director recruitment and program advisory committee process. The Board requested to review the recommended associate director candidates and take action at the May meeting.

Community Engagement Project Manager Ashley Kvitek provided updates on the development of new collateral to use in outreach, including the new <u>Annual Report</u> and rack cards available in English and Spanish. She shared about the newly available hats and

magnets. She also provided an update on the website redesign timeline. Lastly, she invited the Board to participate in Napa RCD sponsored Earth Day activities occurring April 22-24.

B. Huichica Creek Vineyard update.

Executive Director Lucas Patzek shared that all vines and related infrastructure have been removed from 9.6 acres. The young chardonnay block and cider apples will continue to be managed. Cover crop seeding on the remaining acres will occur in the fall. Napa RCD will move forward with its Request for Ideas process to solicit partnership concepts from the community. At its May meeting the Board will be asked to take action to release the commitment to available fund balance of the \$100,000 committed to HCV improvements.
