A. Approve airline travel for Eric McKee to the Annual Statewide Conference of the California Association for Environmental & Outdoor Education.

Napa RCD's Policy No. 2055 requires board approval for staff travel to conferences outside the geographical area that includes the Sacramento/Santa Rosa/San Francisco Bay area. Eric McKee, Education Project Manager, wishes to fly to Irvine, CA to attend the Annual Statewide Conference of the California Association for Environmental & Outdoor Education in May 3-5, 2024. The content of this conference is relevant to Napa RCD's youth education programming and in line with Eric's professional development plan. All travel expenses will be covered by Napa RCD's general fund.

B. Approve travel for Alison Blodorn to the 2024 Wildland Urban Interface (WUI) Conference.

Alison Blodorn, Principal Forestry Program Manager, wishes to travel to Reno, NV to attend the WUI Conference in March 26-28. The content of this conference is relevant to the Forest Health Program and in line with Ali's professional development plan. All travel expenses will be covered by an existing grant.

A. Updates about the North Coast Soil Hub and potential action to adopt Memorandum of Agreement and authorize Executive Director or designee to enter into the MOA. Lucas Patzek

The North Coast Soil Hub (NCSH) is a collaboration between the Resource Conservation Districts (RCDs) in California's Humboldt, Lake, Marin, Mendocino, Napa and Sonoma counties having the purpose of advancing soil health and agricultural resilience. The purpose of this MOA is to establish procedures surrounding stewardship of the brand and identity of the collaborative, as well as fund development activities to raise unrestricted funds, donated services, or any other in-kind contribution in support of the work of the North Coast Soil Hub (NCSH) and partner Resource Conservation Districts (RCDs) and to

create mechanisms to distribute donated funds, goods, or services to the parties to this agreement in a transparent and effective manner.

B. Presentation of the draft Employee Handbook. Trish Griffus, The Personnel Perspective

The purpose of the Employee Handbook is to familiarize staff with the District's policies, practices and benefits, and it supersedes all previously issued policies and practices. This draft has been reviewed by the Policy Advisory Committee and leadership staff.

C. Potential action to adopt amended FY23-24 Salary Level and Step Schedule. Lucas Patzek

Staff recommends creating the new position classification Accounting and Administration Specialist, and removing the classifications Office Manager I/II and Forestry Program Manager I/II/III. The Accounting and Administration Specialist will be supervised by the Finance Manager position, and this staffing structure has been conceptualized through the Fiscal Infrastructure Review.
