### A. Presentation and possible action to adopt the fiscal year 2024-2025 budget and salary schedule. Lucas Patzek

A draft budget for the 2024-2025 fiscal year was reviewed by the Board of Directors at its noticed May meeting and Napa County's Auditor-Controller, and was further amended by staff. The current draft budget is recommended for adoption by the District Board. After adoption it will be submitted to the Napa County Auditor Controller's Office before the end of the current fiscal year. Budgeted revenues are \$8,525,220 (\$7,345,179 from intergovernmental agreements, \$688,000 non-intergovernmental agreements, donations, and other sources, and \$492,041 taxes, dividends, and interest. Budgeted expenses are \$8,212,207 (\$2,222,867 in salaries and employee benefits, \$2,700,800 in services, \$3,288,540 in supplies and other, including contributions and community grants to other agency and nonprofit partners).

#### 4. CONSENT CALENDAR

All items on the consent calendar are considered ministerial or non-substantive and subject to a single motion approval. With the concurrence of the Chair, a Director may request discussion of an item on the consent calendar.

## A. Authorize Executive Director to execute Agreement No. 2024013 with Conservation Corps North Bay.

Napa RCD wishes to obtain specialized services from Conservation Corps North Bay to implement a habitat enhancement project at Devaux Vineyard. Agreement No. 2024013 shall expire on December 31, 2024 and shall not exceed \$24,900. The funding source is the Napa Valley Vintner's Healthy Community Fund for the "Fire Road Fuel Breaks & Forest Health in Napa County."

# B. Authorize Executive Director to execute Right of Entry Agreements for the Devaux Vineyard project.

Napa RCD desires to gain access to the real properties owned by Devaux Vineyards at 550 Sonoma Highway for the purpose of implementing a habitat enhancement project.

# C. Authorize Executive Director to execute Amendment No. 2 to Agreement No. A24-1207-S004 with The Regents of the University of California (University).

Napa RCD entered into Agreement No. A24-1207-S004 with University to support the project entitled "Resilient and Equitable Urban Stream Corridors". The purpose of Amendment No. 2 is to provide additional funding in the amount of \$ 99,769 and to extend the expiration date for continued activities listed in the Agreement.

## D. Authorize Executive Director to execute a Framework Agreement with Shute, Mihaly & Weinberger LLP (Firm).

Napa RCD desires legal services from the Firm related to the Sulphur Creek bridge project, including developing landowner agreements and assisting with public contracting, as well as with other resource conservation projects. When possible, legal services will be billed against existing grants and contracts.

#### 5. BUSINESS

## A. Discuss and select recipient(s) of Napa RCD's Scholarship for Emerging Environmental Leaders. Eric McKee

Napa RCD has dedicated scholarship funds to celebrate the contributions of young leaders who have partnered with it to voluntarily care for Napa County's land, water, soil, wildlife, and people. This scholarship is open to students graduating from any high school, high school equivalent, or GED program in Napa County who also satisfy certain requirements defined in the scholarship application. This year there were 15 total applications, and 2 qualified scholarship applicants were selected by a staff review panel. Staff recommends that both be awarded at \$1,000 each. Additionally, we are forming a scholarship committee and seek directors and associate directors to help envision, collaborate, research, and discuss opportunities for improving the relevance and equitability of Napa RCD's scholarship program.
