#### 1. CALL TO ORDER, ROLL CALL

- **A. Call to order and roll call** The meeting is to be called to order by the Chair at 8:00 A.M., the new District Secretary Tatia Wieland will introduce herself and will take attendance.
- **B.** Approval of the agenda The Board will consider approval of the agenda for this meeting.
- **C. Approval of meeting minutes** The Board will consider approval of minutes from the June 13, 2024 regular meeting.
- **D. Ratification of District bills** The Board will review and ratify bills approved by the Executive Director.
- **E. Approval of District bills** The Board will review and consider approval of the District bills for June 2024.

#### 2. PUBLIC COMMENT

#### 3. CONSENT CALENDAR

All items on the consent calendar are considered ministerial or non-substantive and subject to a single motion approval. With the concurrence of the Chair, a Director may request discussion of an item on the consent calendar.

## A. Authorize Executive Director to execute Amendment No. 2 for agreement California Association of Resource Conservation Districts (CARCD).

Napa RCD entered into an agreement with CARCD in May 2023 to provide technical assistance to applicants to the Emergency Forest Restoration Program (EFRP) in Napa County impacted by the Glass and LNU Fires. EFRP is a program of the USDA Forest Service, and CARCD entered into a cooperative agreement with that federal agency to support EFRP delivery statewide. Amendment No. 2 increases the budget and modifies the termination date of the original Agreement.

## B. Authorize Executive Director to execute Amendment No. 1 for Agreement No. 2023011 with the Land Trust of Napa County.

Napa RCD entered into a professional services agreement with the Land Trust of Napa County (LTNC) in June 2023 to partner in implementing a habitat enhancement project on the LTNC's Linda Falls Preserve. Amendment No. 1 increases the budget and scope, expanding the project footprint from 137 acres to 337 acres. Habitat enhancement activities supported include grazing, manual control of invasive weeds, and oak planting and protection. The funding source is Agreement No. 2023009 with the Napa Valley Vintners Healthy Community Fund.

## C. Authorize Executive Director to execute any agreements with the City of Napa for forest management planning and implementation at Westwood Hills Park.

Napa RCD is partnering with the City of Napa to support forest management planning and implementation at Westwood Hills Park at 3107 Browns Valley Rd. The first phase of this will involve the development of a Forest Management Plan for the park, funded through the Regional Forest and Fire Capacity Grant Program Agreement No. 3020-1005 with the California Department of Conservation. The second phase will involve implementing high priority vegetation management activities, informed by the Forest Management Plan, funded through a State Coastal Conservancy block grant awarded to Humboldt RCD on behalf of the North Coast Durable Collaborative. Napa RCD desires to authorize Executive Director to execute agreements with the City of Napa in support of this work.

## D. Authorize Executive Director to execute Agreement No. 2024015 with Clifton Environmental.

Napa RCD wishes to obtain specialized services from Clifton Environmental to develop a Forest Management Plan for the City of Napa's Westwood Hills Park. Agreement No. 2024015 shall expire on December 31, 2025 and shall not exceed \$17,000. The funding

source is the Regional Forest and Fire Capacity Grant Program Agreement No. 3020-1005 with the California Department of Conservation.

## E. Authorize Executive Director to execute Right-of-Entry Agreement with C. Mondavi and Sons Inc. DBA Charles Krug Winery.

Napa RCD is contracted with the City of St. Helena to conduct stream channel assessments and topographic surveys of York Creek and the surrounding landscape, and desires to conduct field surveys on the property of C. Mondavi and Sons Inc. DBA Charles Krug Winery.

## F. Authorize Executive Director to execute Amendment No. 1 to Agreement No. 230007B with Napa County Flood Control and Water Conservation District (FCD).

Napa RCD entered into Agreement No. 230007B with FCD on July 21, 2022 to support the maintenance of the Napa Valley Regional Rainfall and Stream Monitoring System, carry out stream gauging work at select ALERT sites, provide monitoring and modeling services for FCD's Stream Maintenance Program (SMP) and other projects, and support the Napa

Countywide Stormwater Pollution Prevention Program. The purpose of Amendment No.1 is to extend the term to June 30, 2025 and modify the maximum budget amount to account for new activities.

- d. 10 min: Napa Climate NOW! board members Jim Wilson and Chris Benz will present on the organization's goals and projects.
