A. Appoint Director Paul Asmuth to the standing Finance Committee and accept Director Jim Lincoln's resignation.

These actions would result in the standing Finance Committee being composed of the following members: Directors Rainer Hoenicke and Paul Asmuth and Associate Director Joe Nordlinger.

B. Authorize Napa RCD's Executive Director or their designee as a representative of Napa RCD to conduct negotiations, execute, submit, and sign all documents related to NOAA Award No. NA24NMFX463C0003.

Napa RCD was awarded competitive Award No. NA24NMF4630003 to implement the Napa River Watershed Fish Passage Restoration Project. The award totals \$6,676,482 and the project period is 08/01/2024 – 12/31/2028. Documents which may be necessary for the completion of the Project may include but are not limited to agreements, amendments, payment requests, vendor contracts, landowner site access agreements and permits.

C. Authorize Napa RCD's Executive Director or their designee to negotiate and execute amendment to Lease Agreement with Theodore L Edwards LLC.

Napa RCD entered into a five-year Lease Agreement with Theodore L Edwards LLC on January 1, 2023 for Suites 100B and 700B, located at The Jefferson Office Centre, 1303 Jefferson St., City of Napa, County of Napa, State of California. Napa RCD wishes to amend this Lease Agreement to add Suite 120B, providing an additional 323 sq ft for a combined total of 2067 sq ft. This amendment adds about \$1052 to the current monthly rent.

Staff recommends appointment of Executive Director Lucas Patzek as the voting presentative and a board member as an alternate.
