1. CALL TO ORDER, ROLL CALL

2. PUBLIC COMMENT

3. CONSENT CALENDAR

All items on the consent calendar are considered ministerial or non-substantive and subject to a single motion approval. With the concurrence of the Chair, a Director may request discussion of an item on the consent calendar.

A. Ratify Sonoma Valley Wholesale Nursey Agreement No. 2024019.

Napa RCD wishes to obtain specialized services from Sonoma Valley Wholesale Nursery to source and deliver plants to project sites for Napa RCD's Fall 2024 habitat enhancement projects. Agreement No. 2024019 shall expire on May 31, 2025 and shall not exceed \$15,122,02. Executive Director Patzek signed this Agreement on August 7, 2024.

B. Authorize Executive Director to execute Agreement No. 24-C25 with the Napa Valley Transportation Authority.

NVTA wishes to obtain specialized services from Napa RCD services to provide maintenance of tree plantings annually from 2024 through 2027. Agreement No. 24-C25 shall expire on December 31, 2027 and shall not exceed \$63,000.

C. Authorize Executive Director to execute an amendment to the Regional Forest and Fire Capacity Memorandum of Agreement (MOA) and any future MOA amendments.

Napa RCD entered into a MOA in July 2023 with Colusa RCD, Solano RCD, Sonoma RCD, Yolo RCD, and the Clear Lake Environmental Research Center for our Regional Forest and Fire Capacity program block grant awarded to Napa RCD by the California Department of Conservation. Napa RCD desires to amend the current MOA to update the scope of work, and seeks authorization for the Executive Director to execute any future amendments to the MOA.

D. Authorize Napa RCD's Executive Director or their designee as a representative of Napa RCD to conduct negotiations, execute, submit, and sign all documents related to contract with City of Napa to provide services related to a Planning and Capacity Building Project funded by a grant from the California Air Resources Board (CARB).

City of Napa was awarded a competitive grant from CARB's Planning and Capacity Building Grant Program to develop an Electric Vehicle and Ebike Charging Plan focused on developing charging infrastructure for low-income communities. Napa RCD partnered with City of Napa on the grant application. Napa RCD's scope of work includes assisting with relationship-building with and engagement of community-based organizations to develop a representative plan. The contract value is \$102,580 and the project period is September 2024 to September 2026. Documents which may be necessary for the completion of the Project may include but are not limited to agreements, amendments, payment requests, and vendor contracts. E. Adopt Resolution No. 2024-03 approving application for grant funds from the Bureau of Reclamation (BoR) for the "Developing a New Watershed Group in the Napa River Watershed of California" Project.

Napa RCD partnered with the non-profit organization Abuelitos Foundation and received input from my partner organizations, farmers, and landowners over the past year to conceptualize the development of a new nonregulatory, grassroots watershed group. Napa RCD worked with Abuelitos Foundation to develop and submit a grant application to the WaterSMART Cooperative Watershed Management Program Phase I. This grant program requires that the applicant provide prior to award an official resolution adopted by its governing body with the terms included in Resolution No. 2024-03.
