Adopted Resolution No. 2024-04 establishes a Huichica Creek Preserve Advisory Committee to provide input related to restoration planning, implementation, maintenance and monitoring, public access, community engagement and research programming, and other aspects of its property. No more than three directors, any interested associate directors, and up to five members of the public with the knowledge and expertise needed to advance the goals of this property may be appointed to this Advisory Committee. A local coalition has been advocating for the exploration of whether a Habitat Conservation Plan (HCP) or Natural Community Conservation Plan (NCCP) is a useful and efficient tool for preventing the decline of rare and endangered species in Napa County. The U.S. Dept. of Fish and Wildlife (USFWS) operates the Conservation Planning Assistance Grant Program which could fund the preparation of a Technical Report for Preliminary Strategic Planning to gather the necessary data to determine the challenges and possibilities of an HCP/NCCP.
